### New Partnerships Advance MSTS Research Mission

#### MSTS and the Musculoskeletal Transplant Foundation Announce New Grant

MSTS and MTF have partnered to promote musculoskeletal oncology research (basic or clinical) related to transplantation of allografts, bone regeneration, and biologic reconstruction. This new grant mechanism is currently accepting applications. Funding of up to \$100,000 per year is provided by MTF. MSTS will peer review and select

the grant(s) to be funded. This collaboration supports our mission of fostering research in our field and is the culmination of a dialogue that was initiated by Ed Cheng when he was president several years ago. In contrast to the MSTS Clinical Research Grant, the MSTS-MTF grant is open to both MSTS members and nonmembers.

## Treasurer's Report

MSTS has had a productive start to the year and the finances remain strong. Current assets have increased and exceed \$1.2M. Thank you to our membership for a successful Specialty Day. The Finance Committee has made a substantial effort to reinforce fiscal responsibility, monitor MSTS investments, and develop long-term funding plans. Thanks to the dedication of the members of the MSTS Finance Committee, **Drs. George Calvert, Howard Rosenthal, and Ross Wilkins** and the MSTS management team and leadership, we are ahead of budget. We look forward to a fruitful Annual Meeting this fall.

The Finance Committee is reviewing a long-term funding mechanism for research and is considering options at this time.

## President's Report, cont'd from pg. 1

Albany Medical Center organized the second annual Team Sarcoma 5K walk, which raised over \$40,000 to support basic research in sarcoma. Over 400 walkers and runners participated in the event at Saratoga Spa State Park on July 11 to honor former patient Parker Hayes. Matt has partnered with MSTS to coordinate another new grant to support sarcoma research. Tax deductible contributions to the event are still being accepted and checks can be made out to MSTS. More to come on this new grant later this year. In the meantime, congratulations to Matt for raising sarcoma awareness and organizing a successful event. Perhaps this is a model that could be reproduced around the country to support the MSTS research mission!

### Coding and Evidence Based Medicine Committees Revamped

Our committees are the backbone of the MSTS. My gratitude goes out to those who volunteer to serve on and chair our committees, which bring our programming to fruition. As part of our strategic plan, many of the committees have been expanded to increase opportunities for participation and increase our effectiveness. In order to help out our younger members and help all of us deal with the changing practice environment, Coding Committee Chair John Heiner has led an expansion of his committee into the **Practice Management Committee**, which will continue to work on coding issues, but will also be a resource regarding employment options and negotiations, contracting and insurance interfaces, compliance, and practice models. There will be a session on some of these topics at Specialty Day.

Quality and patient safety initiatives factor into the value equation, bundled payments, and pay for performance. Clinical practice guidelines (CPGs), Appropriate Use Criteria (AUCs), and systematic reviews provide the rationale for these programs. The **Evidence Based Medicine Committee** has been expanded and formalized with three year terms, a chair, and will be involved with CPGs and AUCs relating to our field. The MSTS recently applied to the AAOS for grants to develop Imaging Guidelines and improve access to Custom Devices, both quality improvement initiatives that would come under the EBM committee.

There are many opportunities for involvement with the MSTS. The Call for Volunteers has been announced. Apply for a committee or officer position. It is through the organized, systematic, and regular meetings of a committee with staff support that we can advance our programs.

### 2015 Annual Meeting

The program committees under the direction of Parker Gibbs and Mark Scarborough are busy with final preparations for the combined meeting with ISOLS in Orlando, October 6-10. The scientific, educational, and social programming are outstanding. This is one meeting (actually two) not to miss. Don't forget the early registration deadline (August 17) and discounted fee. If you have submitted an abstract, take advantage of the opportunity to submit your paper now to *CORR* for consideration to be included in the meeting proceedings. There are many advantages to publishing in our official journal.

It has been a great year for the MSTS. I have enjoyed working with all of you, and especially my colleagues on the executive committee and our AAOS support staff. I am looking forward to seeing you in Orlando.

The MSTs Research Committee has been working towards the goal of advancing collaborative research in our Society, as well as basic research and mentoring opportunities. Please see below for a summary of the opportunities available to MSTs members.

## FUNDING OPPORTUNITY ANNOUNCEMENTS

We are pleased to announce three new funding opportunities for MSTs Members! Specific Requests for Proposals will be distributed according to the grant timelines outlined below.

### MSTs/MTF RESEARCH GRANT

#### Funding

\$100,000 grant over 1-2 years

#### Grant Description

MSTs in partnership with the Musculoskeletal Transplant Foundation (MTF) offers seed money for new investigators conducting research in musculoskeletal oncology research related to transplantation of allografts, bone regeneration, and biologic reconstruction.

#### Criteria

1. Research may be basic or clinical.
2. Clinical relevance must be clearly noted in the abstract and specific aims and be obvious from the title and study design.

#### Who Applies?

- Principal Investigator (PI) or Co-Principal Investigator (Co-PI) must be an orthopaedic surgeon
- PhDs and DVMs are eligible to serve as PI but must have a primary academic appointment in an orthopaedic department and the Co-PI must be an orthopaedic surgeon.

search and Education Foundation (OREF) is offering grants to clinician researchers focused on clinical topics in orthopaedic oncology

#### Criteria

1. Prospective clinical study involving multi-center collaboration.
2. Established infrastructure in place.
3. MSTs clinical research priorities focus on randomized trials.

#### Who Applies?

- PI or Co-PI must be an orthopaedic surgeon.
- PhDs and DVMs are eligible if affiliated with an orthopaedic department and working with an orthopaedic surgeon.
- PI or Co-PI must be an MSTs member in good standing.

The Alliance for Clinical Trials in Oncology (Alliance) is one of the five National Cancer Institute sponsored cooperative research groups in the United States conducting large multicenter trials in oncology. The Alliance's Experimental Therapeutics Committee focuses on rare cancers. Relevant to sarcoma, they have recently launched a trial for patients with desmoid tumors or aggressive fibromatosis – **Alliance A091105: A Phase III, Double Blind, Randomized, Placebo-Controlled Trial of Sorafenib in Desmoid Tumors or Aggressive Fibromatosis (DT/DF)**. ## IlluminOss Clinical Trial

All MSTs members are invited to participate in a FDA approved trial sponsored by IlluminOss Medical as part of its FDA approval process. The trial is an 80-patient, 15-site prospective single arm study of patients with metastatic lesions of the humerus (fractures and impending fractures) that will undergo stabilization with the IlluminOss stabilization system. This system involves minimally invasive insertion of a balloon catheter which is then filled with a liquid polymer that will harden into an intramedullary nail in situ via UV light polymerization. Further internal stabilization will be based on surgeon preference for each case. The primary outcome will be change in VAS pain scores and safety data will be examined. Specific benefits for MSTs members involve hands-on education in the process of clinical trial participation. 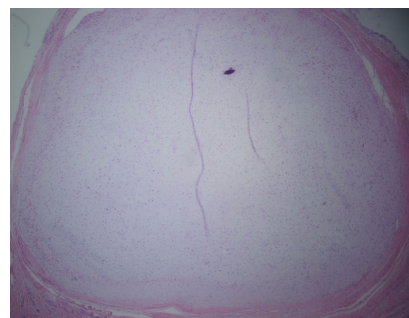
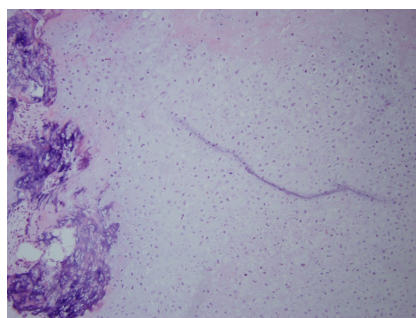

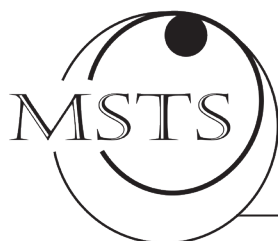
